INTENDED USE

Mouse Monoclonal Antibody for use in the ELISA and bacterial strain identification for Pneumococcal polysaccharide (18C).

CAUTION

This preparation is not for administration to humans or animals in the human food chain. This reference contains material from murine origin. As with all materials of biological origin, this preparation should be regarded as potentially hazardous to health. IMMUNOGEN

Serotype 18C of Pneumococcal capsular polysaccharide (PCPS)

MATERIALS

Mouse IgG, produced by a monoclonal hybridoma cell and purified from mouse ascites by Protein G column, in 10 mM Tris-glysine-HCL, 0.01% NaN_{3.}

SPECIFICITY

Recognizes the serotype 18C of PCPS specifically, no cross reactivity with 23 other serotypes of PCPS(1, 2, 3, 4, 5, 6A, 6B, 7F, 8, 9N, 9V, 10A, 11A, 12F, 14, 15B, 17F, 19F, 19A, 20, 22F, 23F, 33F etc).

UNITAGE

1mg/vial at 1 mg/mL.

USE OF MATERIAL

The material can be diluted 1:2000 for Indirect ELISA. However where possible the user should determine the working dilution depending on the requirements of the bacterial strain identification assays.



CONTENTS

Country of origin of biological material: People' s Republic of China.

STORAGE

The material should be stored frozen at -20 °C. Once thawed, keep at 4 °C to avoid freezing and thawing. Material type: Liquid – will be shipped according to the storage and shipping conditions of the product

STABILITY

The materials are stable for 2 years at -20°C, 3 months at 4 °C and 2 weeks at room temperature.
